


Fig. 1. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values





Fig. 2. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values







Fig. 5. Reverse current as a function of reverse voltage; typical values







Average forward current as a function of Fig. 9. ambient temperature; typical values










